RECOMMENDING THE AWARD OF CONTRACT TO LSERV CORPORATION FOR THE PROJECT "PROVISION OF JANITORIAL SERVICES FY 2024"

WHEREAS, the National Parks Development Committee, through the Bids and Awards Committee (Committee, for brevity) advertised the Invitation to Bid for the **"Provision of Janitorial Services FY 2024"** and posted the same in the NPDC website and Facebook page, the PhilGEPS with Reference No. 10335801 and in conspicuous places at the premises within National Parks Development Committee;

WHEREAS, in response to the said advertisement, one (1) interested bidder, LSERV Corporation attended the Pre-Bid Conference held at the Rizal Park Open Air Auditorium scheduled on 28 November 2023;

WHEREAS, two (2) bidders namely LSERV Corporation and Euro Janitorial Services participated in the bidding and submitted their Technical and Financial documents on 11 December 2023 at the Bulwagan ng Kagitingan, Rizal Park Luneta;

WHEREAS, upon evaluation and checking using pass/fail criterion of the Technical and Financial Documents submitted by the bidder, Industro, Incorporated is found eligible to participate in the bidding and has the following bid proposal:

WHEREAS, the Committee's Technical Working Group (TWG) conducted the post-qualification on the two (2) bidders and submitted a bid evaluation report on 03 January 2024;

WHEREAS, the bid of Euro Janitorial Services has failed the following criteria for post qualification: the allocated discount was not stated in the bid price, contrary to the Item No. 1 of the issued Supplemental Bid Bulletin, and declare that its bid is non-responsive;

WHEREAS, after the conduct of post-qualification process, the Committee has determined that LSERV Corporation has passed all the criteria for post qualification and declare that its bid is a lowest calculated and responsive bid, which shall be considered for award if it falls under Section 36 of Republic Act (RA) No. 9184: Single Calculated/Rated and Responsive Bid Submission;

WHEREAS, due to the exigency of service and the belated approval of the General Appropriations Act of 2024, there is a change of contract duration from 12 months to 11 months which resulted to the new contract amount of Eight Million Nine Hundred Seventy Thousand Four Hundred & 56/100 Pesos Only (Php 8,970,400.56).

NOW, THEREFORE, THIS COMMITTEE RESOLVES AS IT HEREBY RESOLVED, to recommend the award for **"Provision of Janitorial Services FY 2024"** in the amount of **EIGHT MILLION NINE HUNDRED SEVENTY THOUSAND FOUR HUNDRED & 56/100 PESOS ONLY (PHP 8,970,400.56)** to **LSERV Corporation** subject to mutually agreed terms and conditions.
