RECOMMENDING THE AWARD OF CONTRACT TO INDUSTRON, INC. FOR THE PROJECT "OPERATION AND MAINTENANCE SERVICES FOR THE MUSICAL DANCING FOUNTAIN OF RIZAL PARK FOR FY 2024"

WHEREAS, the National Parks Development Committee, through the Bids and Awards Committee (Committee, for brevity) advertised the Invitation to Bid for the **"Operation and Maintenance Services for the Musical Dancing Fountain of Rizal Park for FY 2024"** and posted the same in the NPDC website and Facebook page, the PhilGEPS with Reference No. 10335679 and in conspicuous places at the premises within National Parks Development Committee;

WHEREAS, in response to the said advertisement, one (1) interested bidder, Industron, Inc. attended the Pre-Bid Conference held at the Rizal Park Open Air Auditorium scheduled on 28 November 2023;

WHEREAS, one (1) bidder namely Industron, Inc. participated in the bidding and submitted their Technical and Financial documents on 11 December 2023 at the Bulwagan ng Kagitingan, Rizal Park Luneta;

WHEREAS, upon evaluation and checking using pass/fail criterion of the Technical and Financial Documents submitted by the bidder, Industron, Incorporated is found eligible to participate in the bidding and has the following bid proposal:

WHEREAS, the Committee's Technical Working Group (TWG) conducted the post-qualification on Industron Inc. on 27 December 2023 and submitted a bid evaluation report on 03 January 2024, who passed the Technical and Financial evaluation;

WHEREAS, after the conduct of post-qualification process, the Committee has determined that Industron, Incorporated has passed all the criteria for post qualification and declare that its bid is a single calculated and responsive bid, which shall be considered for award if it falls under Section 36 of Republic Act (RA) No. 9184: Single Calculated/Rated and Responsive Bid Submission;

WHEREAS, due to the exigency of service and the belated approval of the General Appropriations Act of 2024, there is a change of contract duration from 12 months to 11 months which resulted to the new contract amount of Seven Million Six Hundred Eight Thousand Three Hundred Thirty-Three & 33/100 Pesos only (Php 7,608,333.33).

NOW, THEREFORE, THIS COMMITTEE RESOLVES AS IT HEREBY RESOLVED, to recommend the award for **“Operation and Maintenance Services for the Musical Dancing Fountain of Rizal Park for FY 2024”** in the amount of **SEVEN MILLION SIX HUNDRED EIGHT THOUSAND THREE HUNDRED THIRTY-THREE & 33/100 PESOS ONLY (Php 7,608,333.33)** to **Industron, Inc.** subject to mutually agreed terms and conditions.
