**WHEREAS**, the National Parks Development Committee, through the Bids and Awards Committee (Committee, for brevity) advertised the Invitation to Bid for the **"Supply and Delivery of Four (4) Units Brand New Air-Conditioned Passenger Vans"** and posted the same in the NPDC website, the PhilGEPS with Reference No. 10453755 and in conspicuous places at the premises within National Parks Development Committee;
