Contract Agreement No. 5

Series of 2024

This Contract Agreement made this FEB 07 2024 between the **NATIONAL PARKS DEVELOPMENT COMMITTEE**, a government agency with office address at NPDC Executive Office, Rizal Park Luneta, T.M Kalaw Street, Manila, Philippines 1000, represented in this act by its Executive Director, **CECILLE A. LORENZANA-ROMERO**, hereinafter referred to as **NPDC**; and **TOYOTA PASONG TAMO, INC.**, existing under the laws of the Republic of the Philippines, with business address at 2292 Pasong Tamo Ext., Makati City, represented herein by its Marketing Professional, **MICHAEL R. RIVERA**, duly authorized for the purpose, hereinafter referred to as the **SUPPLIER**;

WHEREAS, the **NPDC** invited Bids for certain goods and ancillary services, particularly for the **"Supply and Delivery of Four (4) Units Brand New Air-Conditioned Passenger Vans"** and has accepted a Bid by the **SUPPLIER** for the supply of those goods and services in the sum of **TEN MILLION FIFTY-EIGHT THOUSAND SIX HUNDRED FORTY-EIGHT PESOS ONLY (PHP 10,058,648.00)**, hereinafter referred to as the **"Contract Price"**.

NOW THIS CONTRACT AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Contract Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Contract Agreement, viz.:
 - (a) The contractor's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. contractor's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
 - (b) The Schedule of Requirements;
 - (c) The Technical Specifications;
 - (d) The General Conditions of Contract;
 - (e) The Special Conditions of Contract;
 - (f) The Performance Security; and
 - (g) NPDC's Notice of Award
3. In consideration of the payments to be made by the **NPDC** to the **SUPPLIER** as hereinafter mentioned, the **SUPPLIER** hereby covenants with the **NPDC** to

provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract Agreement.

4. The **NPDC** hereby covenants to pay the **SUPPLIER** in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract agreement at the time and in the manner prescribed by the contract,
